SPECIAL NEEDS AND CONDITIONS

This tour is designed to be enjoyable for travelers of many ages and abilities. That said, some historic theatres and buildings may have limited accessibility, and certain venues may not meet U.S. accessibility standards. If you use mobility assistance or have any physical or medical considerations, please let Goodspeed know as early as possible so we can plan thoughtfully and support you as best we can.

CHANGE TO ITINERARY

Goodspeed Musicals will not provide a refund for any transportation, hotel reservations, sight-seeing or any other unused Tour services if prior arrangements are not made.

CANCELLATIONS

Cancellations must be in writing. Your trip deposit is \$1,000 tax-deductible gift to Goodspeed and is non-refundable.

- 90+ days: 75% refund (excluding gift)

- Up to 30 days: no refund

TRAVEL DOCUMENTS

For international travel a valid passport with an expiration date 6+ months from last day of travel is required. U.S. citizens traveling to the UK for tourism require an Electronic Travel Authorization prior to travel. It is the responsibility of travelers to arrange for all necessary travel documents.

WAIVER OF RESPONSIBILITY

This waiver applies to participation in the Goodspeed Musicals London & Paris Theatre Fundraising Tour (October 10–21, 2026) and to all goods and services arranged by Goodspeed Musicals, Inc. (“Goodspeed”), including (without limitation) ground transportation, hotel accommodations, theatre tickets, tours, meals, group activities, and any related services (collectively, the “Tour Services”).

1. Air Travel; Independent Providers; Provider Terms Apply

Air travel is not included in the Tour Services. You will arrange your flights either independently or through Sundial Travel Inc. If you use Sundial Travel Inc., your airfare and any related services are governed by Sundial’s terms and the airline’s terms and conditions. Goodspeed arranges certain Tour Services as an organizer only. Tour Services are provided by independent third-party businesses (such as airlines, transportation companies, hotels, restaurants, ticketing vendors, and tour operators). Any tickets, confirmations, waivers, or contracts issued by those providers (and their terms and conditions) are the sole agreement between you and the provider. Goodspeed is not responsible for the acts or omissions of any independent provider.

2. Travel Documents; Health; Fitness to Participate

You are responsible for obtaining and maintaining a valid passport and any required visas, entry documents, health forms, or other travel documentation. You represent that you are physically and mentally able to participate in the trip and that you will disclose to Goodspeed any mobility, accessibility, or medical needs that may reasonably require accommodation for planned group activities. You are responsible for ensuring you have adequate medications and medical supplies for international travel, including prescriptions in original containers where applicable.

3. Assumption of Risk

You understand that travel and group activities involve inherent risks that may result in injury, illness, property loss, or other harm. Risks may include, without limitation, transportation incidents, slips and falls, uneven walking surfaces, stairs, crowds, theft, food-related reactions, communicable disease exposure, delays, cancellations, civil disturbances, acts of terrorism, government actions or regulations, and changes in schedules or venues. You knowingly and voluntarily assume all such risks, whether foreseen or unforeseen.

4. Release of Liability; Covenant Not to Sue

To the fullest extent permitted by law, you release and forever discharge Goodspeed Musicals, Inc., and its officers, directors, employees, volunteers, agents, representatives, and assigns (collectively, the “Released Parties”) from any and all claims, demands, actions, causes of action, liabilities, damages, costs, and expenses of any kind arising out of or related to the trip or Tour Services, including claims for personal injury, illness, death, property damage, delay, inconvenience, or economic loss, whether caused by a provider or otherwise. This release includes claims arising from the negligence of any Released Party, but does not include gross negligence or willful misconduct where such a release is prohibited by law. You agree not to sue or initiate any claim against any Released Party for any matter released herein.

5. Indemnification

You agree to indemnify, defend, and hold harmless the Released Parties from and against any claims, liabilities, damages, losses, costs, and expenses (including reasonable attorneys’ fees) arising out of or related to: (a) your participation in the trip; (b) your violation of any law, rule, or provider policy; or (c) your acts or omissions, including any claims brought by third parties.

WAIVER OF RESPONSIBILITY

6. Delays, Changes, and Cancellations; Force Majeure

Goodspeed may modify schedules, substitute providers, adjust activities, or cancel any Tour Services if circumstances require, including for safety, operational, or vendor-related reasons. Tour Services and venues are subject to change without notice. If a Tour Service is cancelled, Goodspeed will make reasonable efforts to obtain any refunds available from the provider and will pass through any amount actually recovered for the affected portion. You understand that Goodspeed is not responsible for additional costs you incur, including airfare, lodging, meals, or other expenses. Events beyond Goodspeed's reasonable control may include (without limitation) weather, strikes, mechanical breakdowns, public health emergencies, government actions, or security events.

7. Conduct; Compliance; Removal from Trip

You agree to comply with all provider rules, local laws, and reasonable instructions from Goodspeed staff. Goodspeed may decline, accept, or remove any participant from the trip when necessary for safety, compliance, or conduct that disrupts the experience for others. If you are removed or choose to leave early, no refunds will be issued for Tour Services.

8. Insurance; Medical Expenses

Travel insurance (including medical coverage and cancellation/interruption coverage) is strongly recommended. You are solely responsible for all medical costs and related expenses incurred during or after the trip. You understand that U.S.-based health insurance may provide limited or no coverage abroad, and you are responsible for confirming coverage and carrying proof of insurance as needed.

9. Personal Property

You are responsible for your personal belongings at all times. Claims for lost, stolen, or damaged items must be made directly with the relevant provider and are subject to that provider's policies and liability limits.

10. Photo/Video Release

You grant Goodspeed permission to photograph, record, and use your name, image, and likeness in promotional materials, publications, and digital media related to Goodspeed, without compensation, unless you notify Goodspeed in writing before departure that you wish to opt out of this media release.

11. Governing Law; Venue; Severability

This agreement is governed by the laws of the State of Connecticut, without regard to conflict-of-law principles. Any dispute arising from or related to this agreement or the trip shall be brought in the state or federal courts located in Connecticut, and you consent to jurisdiction and venue in those courts. If any provision of this agreement is held invalid, the remaining provisions shall continue in full force and effect.
